After successful execution of the fact finding mission the University of the Punjab and PUM The Netherlands senior experts will draft a mutually to be agreed project plan which will specify the consultancy services and the timeline.

The University of the Punjab in consultation with local representative of PUM-The Netherlands senior experts in Lahore (witness to this MoU supplies PUM-The Netherlands senior experts with a filled out application form. After receipt and approval PUM-The Netherlands senior experts will recommend a senior expert or senior experts. After acceptance of the recommended expert(s) by the University of the Punjab PUM-The Netherlands senior experts will make travel arrangements for the senior expert (s).

The University of the Punjab shall bear the actual bearing & lodging and inland travel expenses of the expert(s) executing the fact-finding mission. PUM- The Netherlands senior experts pays for the airline ticket, visa, daily allowance, insurance, project management and overhead cost.

Unless otherwise terminated earlier, the MoU shall remain effective for a period of one year from the date of signing and will be renewable on mutually agreed terms.

Unless otherwise terminated earlier, the **MoU** shall remain effective for a period of one year from the date of signing and will be renewable on mutually agreed terms.


The **MoU** shall be amended in writing by mutual consent of the parties; each party shall give appropriate consideration to any amendment proposed by other party

Either **Party** may terminate this **MoU** by giving prior notice of reasonable time.




