The following list is of three times of available seats. The merit list will be prepared out of the following list who will be physically present along with all original documents and fee at 10:00 a.m on 29th December (Thursday) in Exam Hall at Punjab University Gujranwala Campus.

The candidates have been selected for admission to B.S (Commerce) Morning Program for the academic year 2022-23, subject to the following conditions:-

1. Any candidate who is found at any time to have obtained admission by making any miss-statement in the Admission Form or by willful concealment of any material fact (particularly about marks, division, previous admission to this or other Department/Center/Institute/College/Campus or employment, expulsion, conviction etc.) shall be dropped from the rolls of Gujranwala Campus.
2. Original Academic Documents and three pictures are required to be submitted to the University Authorities before obtaining Challan Forms for deposit of dues and will be retained by the University for Verification.
3. The students shall have to submit Medical Fitness Certificate & an Original Affidavit (specimen available from the campus office) before Start of the Classes
4. The students shall pay their dues amounting to Rs. 23,539 in Habib Bank Limited, Gujranwala Campus Booth after obtaining necessary Challan Forms from the office, before the close of banking hours by the LAST DATE i.e. Thursday, 29 December 2022.
5. Students are required to submit the photostat copy of Challan in the same office after payment of dues.
6. Those who do not deposit their dues within this period shall lose their right to admission.
7. The University reserves the right to correct any typographical error, omission, etc.
