This is to inform you that worthy Vice-Chancellor University of the Punjab has approved the following schedule for admission to LL.B Part-I (5 Years Program) for the academic session 2022-23.

- a) Date of commencement of admissions: 28-11-2022  
b) Date by which admissions are to be completed: 07-12-2022  
c) **Last date for submission of "Online Registration Return:" 21-12-2022**

#### **LATE ADMISSIONS:**

With regard to late admission made under category (iii) above, the application forms for confirmation of late admission, may also be submitted to this office for necessary action.

#### **Special Note:-**

- Admission must be processed according to the Admission Regulation/Criteria 2022-23.
- **The candidate holding 3<sup>rd</sup> division is not eligible for Admission.**
- Registration Return should be submitted "Online" within the prescribed time as per Schedule.
- **LAT qualified result within two years of issuance of this admission schedule** (as per policy of HEC) will be accepted towards determination of eligibility.
- **True copy of verified documents from the relevant boards** should be provided along with Registration Return.
- The cases of Age relaxation and Session Gap as prescribed in Admission Regulation, must be reach this office collectively within the relevant Admission Schedule along with request of the Head of institutions and all relevant documents.
- As per Admission Regulation, the admission of students of previous sessions can be made by allowing up to the previous 5 years/sessions.

#### **FEES STRUCTURE FOR THE ACADEMIC SESSION 2022-23:**

- i) Registration fee: Rs. 5180/- per student  
ii) Sports fee: Rs. 2500/- per student  
iii) Enrollment fee: Rs. 2500/- per student for Public Sector Colleges  
iv) Enrollment fee: Rs. 5000/- per student for Private Sector colleges

#### **Eligibility for BS or Equivalent**

The candidates holding F.A/F.Sc or equivalent qualification with **at least 2<sup>nd</sup> division and age not more than 24 years** are eligible for admission in ASSOCIATE DEGREE IN ARTS & SCIENCE /BS/BBIT/ ASSOCIATE DEGREE IN COMMERCE / BBA/ BFA/ LLB ( 5 years)/ B.Arch./ or equivalent programs.

## AGE-RELAXATION:

Any person who has attained the age of twenty-six years or more on the last date fixed for the receipt of the applications for admission shall not be admitted to MA/M.Sc or equivalent classes. Any person who has attained the age of twenty-four years or more on the last date fixed for the receipt of the applications for admission shall not be admitted to Associate Degree in Arts & Science or equivalent classes. However, the Vice-Chancellor on the recommendations of the Chairman/Director/Principal and Dean of Faculty concerned, may relax this Regulation for male candidates/female/ foreign candidates / up to a maximum of 2 years for male and 5 years for female candidates seeking admission to the undergraduate/graduate course. No age limit for Disable/Special students. (Vide Notification No. S.O. (A-III) 1-83/2012 dated 07/11/2013 issued by HED).

## Enrollment list of LLB Part II, III, IV and V

As a modified procedure **online Enrollment Return of LL.B. Part-II, Part-III, Part IV and V students must be submitted by the college up to 31-02-2023**, and its hard copy along with relevant documents should reach this office.

## SUBMISSION OF REGISTRATION RETURN:

- a. Subject wise **Online Registration Return** for LL.B Part-I (5 Years Program) class should be feeded separately.
- b. **On Line Registration Return** should be filled in carefully in accordance with the educational documents. **In case of any correction in the Registration return after its submission, correction fee of Rs.100/- per correction will be charged.**
- c. A printout of the submitted Registration Return should also be **dispatched** along with all documents i.e. **attested copies of Matric, Intermediate certificates or Equivalence Certificate issued by the IBCC, CNIC/ B.Form having CNIC number, Original N.O.C. (if required) and system generated bank challan within the schedule.** In case of missing documents a fine of Rs. 300/- per student from the Colleges at Lahore and Rs.200/- per student from the Mufassil Colleges will be charged. **Only system generated challan forms along with the Registration Return will be accepted.**
- d. A fair Photograph of each student (Maximum Allowed File size 200KB) with sky blue background should be uploaded carefully at the proper place during feeding.
- e. All the columns of the online Registration Return should be carefully filled in. In case of missing/wrong entry of any data in the final submitted online Registration Return a fine of **Rs. 100/-** per correction will be charged.
- f. Admission of the students over and above the intake limit is against the rules, therefore the Registration Returns of such students will not be entertained.
- g. Fee must be submitted on the System Generated Bank Challan and complete details of Registration, Enrollment, Sports and Late Admission fee etc should be mentioned in the covering letter.
- h. Registration, Enrollment, Sports and late admission fee shall be deposited by the name of Principal of the college in the authorized bank branches **positively within Admission Schedule.**
- i. The Registration Returns must be inscribed original signature by the Principal of the relevant college.

## College to College Migration


College to college migration shall be proceeded strictly in accordance with statute 14 pertaining to migration from one college to another college stated on Page No. 534, of Punjab University Calendar Volume-I. 2002.

## Special Instructions

At the time of admitting the students it is essential to keep in view **the admission criteria eligibility and age limit. Admission should be processed according to the University Admission Regulations.** These Regulations are available at the University website and University Sales Depot, Allama Iqbal Campus, Lahore.

**Admission against the prescribed rules and regulations will be cancelled at any time and the concerned Directors/Principals/Chairmen of the Institute / College will be informed accordingly. In such situation the responsibility will lie upon the Director/Principal.**
