SUBJECT: ADMISSION TO PHARM-D FOR THE ACADEMIC SESSION 2020-21

Dear Sir/Madam,

I have the honor to inform you that the following admission schedule for Pharm-D Class for the academic session 2020-21 has been approved by the Vice-Chancellor, University of the Punjab:

- a) Date of commencement of admissions: 14-12-2020
b) Date by which admissions are to be completed: 23-12-2020
c) Last date for submission of "Online Registration Return:" 06-01-2021

LATE ADMISSIONS:

Admissions, after the expiry of the last date i.e. **23-12-2021** may be made in accordance with Rule and Regulations relating to late admissions in the Colleges under the following Schedule:

ii.	With Late fee of Rs. 600/-	07-01-2021 to 20-01-2021	03-02-2021
* iii.	With Late fee of Rs. 700/-	21/01/2021 to 20-02-2021	06-03-2021

* (Subject to the sanction of the Vice-Chancellor at the time of admission the last date for submission of late admission form is 20-02-2021)

With regard to late admission made under category (iii) above, the application forms for confirmation of late admission, may also be submitted to this office for necessary action.

- Admission must be processed according to the Admission Regulation/Criteria 2020-21.
➤ Registration Return should be submitted "Online" within the prescribed time as per Schedule.

FEES STRUCTURE FOR THE ACADEMIC SESSION 2020-21:

- i) Registration fee: Rs. 4090/- per student
ii) Sports fee: Rs. 2500/- per student
iii) Enrollment fee: Rs. 2500/- per student for Public Sector Colleges
iv) Enrollment fee: Rs. 5000/- per student for Private Sector colleges

Eligibility.

- i. F.sc Pre-Medical with 60% marks or equivalent examination.
ii. B.Sc after F.Sc Pre-medical 60% marks or equivalent examination.

AGE-RELAXATION:

According to Admission Regulation, Any person who has attained the age of twenty-six years or more on the last date fixed for the receipt of the applications for admission shall not be admitted to MA/M.Sc. or equivalent classes. Any person who attained the age of twenty-four years or more on the last date fixed for the receipt of the applications for admission shall not be admitted to BA/BSc. or equivalent classes. However, the Vice-Chancellor on the recommendations of the Chairmen/Directors/Principals and Faculty concerned, may relax this Regulation for male candidates/female candidates/ foreign candidates/ up to a maximum of 2 years for male and 5 years female candidates seeking admission to the undergraduate/ Graduate Course. No age limit for Disable/Special Students. (Vide Notification No. S.O. (A-III) 1-83/2012 dated 7/11/2013 issued by HED).

SUBMISSION OF REGISTRATION RETURN:

- a. Roll number wise on **Line Registration Return** for Pharm-D classes should be feeded separately.
- b. **On Line Registration Return** should be filled in carefully in accordance with the educational documents. **In case of any correction in the Registration return after its submission, correction fee of Rs.100/- per correction will be charged.**
- c. A printout of the submitted Registration Return should also be **dispatched** along with all documents i.e. **attested copies of Matric, Intermediate certificates or Equivalent Certificate issued by the IBCC, CNIC/ B.Form having CNIC number, Original N.O.C. (if required) and system generated bank challan within the schedule.** In case of missing documents a fine of Rs. 300/- per student from the Colleges at Lahore and Rs.200/- per student from the Mufassil Colleges will be charged. **Only system generated challan forms along with the Registration Return will be accepted now onwards** (letter highlighting generation and submission of challan will be sent separately)
- d. A fair Photograph of each student (Maximum Allowed File size 200KB) with sky blue background should be uploaded carefully at the proper place during feeding.
- e. All the columns of the online Registration Return should be carefully filled in. In case of missing/wrong entry of any data in the final submitted online Registration Return a fine of **Rs. 100/- per correction** will be charged.
- f. Admission of the students over and above the intake limit is against the rules, therefore the Registration Returns of such students will not be entertained.
- g. Fee must be submitted on the Online Bank Challan and complete details of Registration, Enrollment, PUSTC and Late Admission fee etc should be mentioned in the covering letter.
- h. As per admission regulation, the admission of students of previous sessions can be made by allowing up to the previous 5 years/sessions.
- i. Registration, Enrollment, Sports and late admission fee shall be deposited by the name of Principal of the college in the authorized branches and system generated online bank Challan be provided with the Registration Returns.

College to College Migration


Within three months after the last date of admission no students should be recommended for migration from one college to another college. In case of transfer of father of any student, change of residence and some unavoidable circumstances, migration of such students can be recommended with solid proof.

Special Instructions

At the time of admitting the students it is essential to keep in view **the admission criteria eligibility and age limit. Admission may be processed according to the University Admission Regulations.** These Regulations are available at the University website and University Sales Depot, Allama Iqbal Campus, Lahore.

Admission against the prescribed rules and regulations will be cancelled at any time and the concerned Directors/Principals/Chairmen of the Institute / College / Department will be informed accordingly. In such situation the responsibility will lie upon the Director/Principal/Head of the Department.
