- 3. A call deposit amounting to Rs. 100,000/- in the name of the Director General, University of the Punjab Gujranwala Campus is to be enclosed with the quotation/tender which will be kept as security till completion of the contract period. It may be released in case of rejection after decision of the tender. No quotation will be considered valid unless the CDR is found attached. No cheque/performance bond will be accepted against CDR.
- 4. The rates of different fast food items will be provided with the tender form which may be collected from Assistant Treasurer Office at University of the Punjab, Gujranwala Campus. The rates will essentially be not more than general market rates.
- 5. In case of increase or decrease of rates of different items in the market, the Canteen Committee of University of the Punjab Gujranwala Campus will be the competent authority to revise the rates.
- The bidders must already be doing similar work in one or more renowned institutions/ organizations in Gujranwala city, otherwise, the tender will be rejected.
- 7. The Canteen Committee will evaluate the tenders on the basis of experience, quality of already running canteen in Gujranwala and amount of rent quoted by the bidders.
- 8. The Committee will visit the already doing work sites of the bidders in Gujranwala.
- 9. The Committee may call the shortlisted bidders after evaluation of quality of their work for open tendering to finalize the tender within almost a week after last date of submission of tender.
- 10. The successful bidder shall pay the amount of the rent on 1<sup>st</sup> day of each month till the contract period. In case the contractor fails to submit the rent till 5<sup>th</sup> day of a month, his contract will be cancelled without any further warning in this regard.

- 11. The successful bidder will have to pay the electricity and suigas bill (if utilized) within 3 days after issuance of the bills to him.
- 12. Conditional tenders will not be accepted.
- 13. While filling the amount of the rent for the whole contract period, overwriting /overtyping / scratching must be attested under the full signature of the bidder.
- 14. The bidder must attach fresh security clearance certificate from police department.
- 15. The competent authority, Canteen Committee of University of the Punjab, Gujranwala Campus, has unchallengeable rights for formal approval/rejection of any quotation/tender/a part of quotation/tender without assigning any reason at the spot or afterward.
- 16. The contractor shall warrant that the items/ edibles served by him are hygienic in all respects. The cleanliness of the spot must be well ensured.
- 17. The contractor will have to provide furniture for the visitors/ students on the work place. All the expenses of repair and maintenance, if required, shall be borne by the contractor.
- 18. All relevant taxes will be applied for the whole contract period.
- 19. The contract may be cancelled at once by the Canteen Committee in case of noncompliance of any of the above terms without issuing any warning notice.
- 20. Any change/s subsequently made by the Canteen Committee in the terms and conditions will be applicable during the contract period.
