The Historical framework analysis



This term is well explained by the United State Investigation agency called FBI in following words; (Niaz, 2010). This form is associated by some Revolutionists ecologists whose aim is to safe nature at any cast from those who create problematic activities to destroy environment. To save nature is not a new phenomenon for people, it is present from the centuries of man but the term of eco terrorism has not been introduced till 1960. This has been introduced for the first time in history when some civilian take action against those people who wants to destroy the forest land. This insurgency has been continued till five years. It is very dangerous and distinct term of terrorism in which terrorists achieve their goal through spreading poisonous nuclear material in an area. This type of violence activity reached in its extreme point because nuclear weapon has been used to perform this deadly function. Through this insurgency the insurgent spread any kind of nuclear substance released from any nuclear station situated any of their premises on opposite areas. Because it was created a horrible situation, so it was hugely condemned by across the globe. So, during era of 16th July 2006, a worldly recognized institution has been developed by the superpowers named the Global initiatives to Combat Nuclear Terrorism (GICNT). The agenda of this organization was to save the globe from nuclear destructions, many precautionary measures had been taken in this regard by those countries who are part of that organization.(Ran strop, 2020). The recent example of this terrorism has been seen in Kashmir from

1948 where Indian government show its rights upon this state and still try to crush the freedom fighter movements till present day. The term relates an action of in which a state to crush the activities of its own civilians or any group who resides in that state and who challenges the writ of Govt. and involved an activity considered against state functionaries at that time. It is not new act for the people, it has been traced by the history in the year of 1793, when French Govt, crushed the movement at that time. Like every type of terrorism act this also means to create panic, chaos, and fear of instability in public minds to bring out for their illegal political aims. (Lalit, 2019). The reengagement has merged with Pakistan's own reform effort, America's evolving strategic relationship with South Asia, and the broader issue of democracy in the Muslim world. And in Pakistan and beyond, this new relationship collides with the crosscurrents of religious extremism. (Hussain, 2005). It is a kind of religious extremism and these extremists considered that it is holly and divine duty and a sacred action. Religious scholars pass on this thing into to innocent people mind that it is the way of to achieve divinity. Religious extremism is not only problem of Pakistan but also concerned by developing nations too. The very kind of violence is an example that developed with the passage of time and did not reduce in modern times. It is important to know that religion is not an only cause to spread violence, but other elements are also responsible to create this type of situation in the society. There are many things related to above, but I will not discuss them due to shortage of time but try to mention some of the names, right-wing terrorism, left-wing terrorism, pathological terrorism, intimate terrorism and not least but last is separatist terrorism.(Ranstrop, 2020).

Al-Qaeda and its Associates wings

After September 11, the Pakistan army knew its strategic overextension in the region, especially its support for the Taliban and, by implication, al-Qaida, was untenable. But nearly bankrupt, the country had neither the political will nor the resources to take on these forces. Pakistan has cooperated with the United States in several ways, by granting logistics facilities, sharing intelligence, and capturing and handing over al-Qaida terrorists .Al Qaeda is one of the presently well-known active terrorist groups of modern eras. The establishment history of this organization has been very dramatic. Before this many other ethnic groups were in functioning in this regard as such MAK and IIRO etc. Osama bin laden was an Arab by creed he met Dr. Abdullah Azzam during his stay in Afghanistan. Dr Abdullah already had run a jihadi movement Maktab Al Khadimat (MAK) and the main purpose of this organization was to reunite the Muslims of the globe. Osama work under his guidance for many a year but left him due to some conflicts and founded Al Qaeda Al Sulbah after the departure of Russia from Afghanistan in the year of 1989(Aldis &Herd, 2007). The main features and functions of this foundation were to reunite the Muslims under one flag against the rationalists' powers, the imposition of Allah's laws across the land and the globe must be ruled by the Muslims once again. The driving force of this institution was its philosophical thoughts under which anyone can give its life fir it. It's a wellorganized foundation and work under the rule of one powerful blow is comparable to a hundred smaller blows which shake the world like 9\11 attack by it. This foundation was funded by the efforts of Osama by most of the Muslims well renowned Arab states. The particular purpose of this establishment to crush the Russian intervention from Afghanistan but later it participated on those liberation movements which had start fight for their own freedom like Kashmiri freedom movement etc. The important principle under the Al Qaeda network functioned is upon the teaching of Islam which presented a strong belief among Muslims is that

those who gives their lives in the way of Allah does not consider as dead one and even received the title of shaheed under the grace of Allah. This belief has completely ousted the fear of death from them, and they can achieve every kind of impossibility. Pakistan has been facing many difficulties and hazards throughout past regarding the issue of peace and stability. And it is no doubt that the integrity of state is totally depends upon peace of whole region. Pakistan has been notorious in international community that it supports terrorists in past but after the incident committed by Al Qaeda network in 9\11 Pakistan stands side by side with USA in the war against terrorism and loses many valuable lives in it. 
The Afghan Taliban influence and Infiltration

The Kerry-Lugar bill 2009 is an important example in this regard. 

The country has also banned or placed on watch lists a large number of sectarian and militant organizations and has enacted numerous antiterrorism laws, freezing thirty-two bank accounts suspected of belonging to terrorist organizations. Finally, Pakistan is currently creating a national criminal database and is the first country to successfully install PISCES, a terrorist-interdiction program set up at seven Pakistani airports and at border crossings with India. The situation of Pakistan becomes worse due to these countries of region. India creates security hazards in many ways. Afghanistan is still a zone of war from throughout the history, but the situation has become developed after Russian cold war during 1979 and the neighboring country like Pakistan indirect involved in it for its safety and provided them support in every possible means which needs for survival. Pakistan indirect involved in it for its safety and provided them support in every possible means which needs for survival. Pakistan pays a lot during these efforts (Christoph, 2015). The insurgent occupied the northern area of Pakistan as base camps for their terrorist activities and the aftermaths was terrible and horrified which has been proved after.
