PREFACE

Faculty of Pharmacy, University of the Punjab and Isfahan University of Medical Sciences Isfahan Province, Isfahan, Iran are desirous to establish linkage and contacts through a formalized MOU between the two institutions with the following objectives:

1. AIMS AND FORMS OF COOPERATION

1.1 Student Exchange

To enable students from the Faculty of Pharmacy, University of the Punjab and the Isfahan University of Medical Sciences, Isfahan, Iran to spend mutually agreed periods of time at each other's institute to experience teaching, learning, experiential experience and research.

1.2 Academic Staff Exchange

To enable academic staff from both institutions to spend agreed upon periods of time to experience teaching, learning, experiential experience and research.

1.3 Establishment of Pharmaceutical Science Journal

Faculty of Pharmacy, University of the Punjab and the Isfahan University of Medical Sciences, Isfahan, Iran will establish a common pharmaceutical science journal.

1.4 New academic courses in Pharmaceutical Sciences.

Faculty of Pharmacy, University of the Punjab and Faculty of Pharmacy, Isfahan will collaborate in developing new courses, workshops to train students regarding innovative and updated topics in pharmaceutical sciences.

1.5 Collaboration in Research Projects.

Under this agreement, both institutions will explore the possibilities of conducting research project on a collaborative basis, with a view to collaborate in the field of R&D Product development Bio-equivalence/Bioavailability studies, Stability Studies, Quality Control, Clinical Studies and exploration of new molecules.

Both institutions will settle details of such collaboration on a case-by-case basis.

1.6 The Conduct of Special Projects for Mutual Benefit.

Under this arrangement, both Institutions shall explore the feasibility of working together on other projects demand to be mutually beneficial and viable for both institutions.



2. FINANCE

Neither institution shall incur any financial obligation under this agreement. Applications for financial support towards the cooperation and individual activities planned under this agreement will be transparent and undertaken with mutual consent. Other sources of finances raised to support these joint projects can be pursued with the knowledge of the other through intimation in writing.

3. RESPONSIBILITY FOR IMPLEMENTATION

Activities to be organized under this agreement will be the responsibilities of the Heads of both institution or of persons designated by them. National regulations and customs shall be mutually respected.

4. USAGE OF LOGOS

The logos of Faculty of Pharmacy University of the Punjab and the Isfahan University of Medical Sciences, Isfahan, Iran may be used for value-added promotion of the two entities with consent.

5. DURATION AND ALTERATION OF AGREEMENT

The MOU will come into effect on the date of signature by both the parties. The duration is for a period of five (5) years. However, the agreement may be terminated with mutual consent by either party after the completion of any specific activity/activities in progress.
