Certificate / result card, Entry Test result card & Domicile, paid challan / form fee slip, NOC from candidates other than Lahore board) & 3 sets of Photocopies F.Sc & Matric result card/Certificate, entry test result card, domicile, student's CNIC/B.form & father CNIC. An stamp paper of Rs.100/- for Affidavit bearing text given.**
- 3 Students shall pay their dues in the university through Accountant of the Account Office upto **30-11-2023** after obtaining necessary bank challan forms before the close of banking hours & submit the original paid Bank Challan in the Office after this, their admission will be confirmed / completed (Provisionally). Those who do not deposit their dues within this period shall lose their right to admission.
