<p>On the completion of the course, the students will:</p> <ul style="list-style-type: none"> • • Recognize and describe the major Muslim institutions such as the Khilafat (Caliphate), the judiciary, and the Shura (consultative assembly). • Understand the historical development and significance of these institutions in the Islamic world. • Examine the functions and structures of the Khilafat, judiciary, and Shura. • Assess the impact of these institutions on the political, social, and legal aspects of Muslim societies. • Identify and explain the contributions of prominent Muslim philosophers, such as Al-Farabi, Al-Ghazali, and Al Mawardi • Analyze how Muslim philosophers influenced and were influenced by the political and legal institutions of their time. • Understand the role of philosophy in shaping Islamic governance and legal thought. • Read and interpret primary texts related to Muslim institutions and the works of Muslim philosophers. • Extract and summarize key arguments and ideas from these texts. • Illustrate the development of Islamic political, legal, and philosophical thought from the early caliphates to the later medieval period. • Identify influences and connections between different philosophers and their impact on Islamic institutions.
