With the permission of the Chair, the Secretary of the Committee informed the members that same criteria of selection will be applied for the selection of the students with disabilities as per last year practice by the Ex-Committee and members. The criteria issued by the Ex and Present Committee is as follows: -

1. **Severe Disability**
When all the four limbs of the body are disabled/disfigured and are unable to perform normal functions.
2. **Major Disability**
When two or three limbs of the body are disabled. Cases with total blindness or those who are totally deaf and dumb are also included in this grade.
3. **Minor Disability**
One limb is disabled or with total loss of vision in one eye or there is total deafness in one ear or the candidate is dumb. Rheumatoid, Arthritis, Retinitis Pigmentosa of one eye are other examples of minor disability.

The present Committee unanimously approved the previous criteria of definition for selection of the students with disabilities against admission of reserved seats in different departments of the University.

As per the criteria the candidates from different departments were called for examination. Those candidates who had applied for admission more than one department were asked for their preferences regarding admission in different departments. Their preferences were recorded along with their cases. After examining the candidates each candidate was

classified according to the degree of his/her disability and recommendations for admission against the reserved seats in each department were finalized.

List of candidates who have been recommended for admission in **Pharm-D** against the reserved seats by the Committee is given below:
