Authors Guideline

Language

Please write your text in good English (American or British usage is accepted, but not a mixture of these).

❖ Submission

Submission to this journal proceeds totally online. Use the following guidelines to prepare your article. Via the homepage of this journal (http://111.68.103.26/journals//index.php/jfet) you will be guided stepwise through the uploading of the files. All correspondence, including notification of the Editor's decision and requests for revision, takes place by e-mail and via the author's homepage, removing the need for a hard-copy paper trail. Upload your article as a single file including the figures, table.

Originality

Authors are required to submit the plagiarism report using the TURNITIN software. Overall similarity index must be less than 16% with one single source of less than 4%. Please upload the plagiarism report as a supplementary file.

Referees

Please submit, with the manuscript, the names, present affiliation and current addresses and e-mail addresses of at least 2 potential referees (At least one should from technically advanced country). Note that the editor retains the sole right to decide whether or not the suggested reviewers are used.

* Review Procedure

The Executive Editor first evaluates all manuscripts on technical aspects such as compliance to the Guide for Authors, quality of grammar or English language. Revision can be requested after this first evaluation. Manuscripts passing the first evaluation are sent to the handling editor who can reject on the basis of insufficient originality, serious scientific flaws, or because the work is considered outside the aims and scope of the journal. Those that meet the minimum criteria are passed on to experts for review. Referees advise the editor, who is responsible for the final decision to accept or reject the article. Please note: Any Editor's decision is final.

Additional Information

Generally, the size of the manuscript should be minimum of 4 pages and maximum 10 pages as per the provided Journal Template. Abstract should be minimum 150 words and maximum 300 words.

Formatting requirements

There are strict formatting requirements as per the journal template. All manuscripts must contain the essential elements needed to convey your manuscript, for example Abstract, Keywords, Introduction, Materials and Methods, Results, Conclusions, Artwork and Tables with Captions.

If your article includes any Videos and/or other Supplementary material, this should be included in your initial submission for peer review purposes. Divide the article into clearly defined sections.

Figures and tables embedded in text

Please ensure the figures and the tables included in the single file are placed next to the relevant text in the manuscript, rather than at the bottom or the top of the file.

Use of word processing software

Use the MS word (2007/2010/Updated) for the preparation of your articles. To avoid unnecessary errors you are strongly advised to use the 'spell-check' and 'grammar-check' functions of your word processor. Revised manuscripts should use 'tracked changes' tools to make clear where revisions have taken place.

❖ Article structure

Subdivision - numbered sections

Divide your article into clearly defined and numbered sections. Subsections should be numbered 1.1 (then 1.1.1, 1.1.2, ...), 1.2, etc. (the abstract is not included in section numbering). Use this numbering also for internal cross-referencing: do not just refer to 'the text'. Any subsection may be given a brief heading. Each heading should appear on its own separate line.

❖ Title page information

Title. Concise and informative. Titles are often used in information-retrieval systems. Avoid abbreviations and formulae where possible.

Author names and affiliations. Please clearly indicate the given name(s) and family name(s) of each author and check that all names are accurately spelled. Present the authors' affiliation addresses (where the actual work was done) below the names. Indicate all affiliations with a lower-case superscript letter immediately after the author's name and in front of the appropriate address. Provide the e-mail address of each author. **Corresponding author.** Clearly indicate who will handle correspondence at all stages of refereeing and publication, also post-publication. *Ensure that the e-mail address is given and*

that contact details are kept up to date by the corresponding author.

Abstract

A concise and factual abstract is required. The abstract should state briefly the purpose of the research, the principal results and major conclusions. An abstract is often presented separately from the article, so it must be able to stand alone. For this reason, References should be avoided, but if essential, then cite the author(s) and year(s). Also, non-standard or uncommon abbreviations should be avoided, but if essential they must be defined at their first mention in the abstract itself.

Keywords

Immediately after the abstract, provide keywords (min. 4, max. 8), avoiding general and plural terms and multiple concepts (avoid, for example, 'and', 'of'). These keywords will be used for indexing purposes.

❖ Introduction

State the objectives of the work and provide an adequate background, avoiding a detailed literature survey or a summary of the results.

Material and methods

Provide sufficient detail to allow the work to be reproduced. Methods already published should be indicated by a reference: only relevant modifications should be described.

Theory/calculation

A Theory section should extend, not repeat, the background to the article already dealt with in the Introduction and lay the foundation for further work. In contrast, a Calculation section represents a practical development from a theoretical basis.

Results & Discussion

Results should be clear and concise. In this section explore the significance of the results of the work, not repeat them. Avoid extensive citations and discussion of published literature.

Conclusions

The main conclusions of the study may be presented in a short Conclusions section.

Abbreviations

Please elaborate the field-specific terms used in your article in the first sentence concerned.

Appendices

If there is more than one appendix, they should be identified as A, B, etc. Formulae and equations in appendices should be given separate numbering: Eq. (A.1), Eq. (A.2), etc.; in a subsequent appendix, Eq. (B.1) and so on. Similarly for tables and figures: Table A.1; Fig. A.1, etc.

Acknowledgements

Collate acknowledgements in a separate section at the end of the article before the references and do not, therefore, include them on the title page, as a footnote to the title or otherwise. List here those individuals who provided help during the research (e.g., providing language help, writing assistance or proof reading the article, etc.).

Manuscript Preparation

Please read the file "Guidelines for manuscript preparation" and follow the instructions to prepare your manuscript. Please strictly follow the instructions required for **CAMERA READY PRINT.**

❖ Final Submission

Final checking of an article prior to sending it to the journal is necessary to avoid delays in the review process. An article should be reconsidered as per the author's guidelines before submission for review.
